



Dear Community Leader,

Our community service organization, the Parrot Head Club of Baton Rouge, has an exciting event planned for the Spring of 2020. It is our 24th Annual Bike Ride for Our Environment! We are asking for your organization's support to ensure the success of our effort, with proceeds to be donated to the Bluebonnet Swamp Nature Center and the Nature Conservancy of Louisiana.

There are over 200 local chapters of Parrot Head Clubs in the United States, plus several clubs worldwide. The Baton Rouge chapter was formed in October 1994 and we are proud to have nearly 100 active members as of December 31, 2019. Although the underlying draw of the club is a mutual admiration of Jimmy Buffett and his music, the club's focus is to provide voluntary support for local environmental and community concerns. Groups of civic-minded Parrot Heads in cities across the country decide how they can best serve their community. All work is voluntary and all in the name of Jimmy Buffett, a well-known advocate of preserving our environment.

Some of our local club's accomplishments:

- * We have held 23 Annual Bike Rides for Our Environment, raising over \$55,000 for our two primary environmental concerns, while promoting our club and the ride sponsors.
- * We have assisted with trail-blazing projects at the Mary Ann Brown Nature Preserve in St. Francisville to facilitate the trails leading to campsites for youth groups. We have participated in clean-up projects at the LSU Lakes in Baton Rouge and several local roadways. We have also helped with trail clearing for walkways to be built through the Bluebonnet Swamp Nature Center and served as guides for their grand opening. We also helped with their Annual Snake Fest and Rockin' in the Swamp.
- * We have provided Christmas dinners and boxes of food, books, clothes, and toys for several needy families every year since our inception.
- * We have assisted the Alzheimer's Association "Memory Walk" and "Memory Ride" (by walking in the Walk, providing general assistance, and serving lunch) for the last 19 years. We assisted the Children's Miracle Network by cooking and serving food at the CMN corporate volleyball tournament for 10 years. We have helped as volunteers for the St. Jude's Dream Day Fishin' Galore the last 16 years.
- * We were honored by Volunteer Baton Rouge in December 1999 as volunteer group of the month, received the "Angel Award" from Alzheimer's Association in 2001 and awarded a plaque of appreciation from Bluebonnet Swamp Nature Center in 2005.

The event that we are planning for March 28, 2020, will be a repeat of the last 23 years' events, only bigger and better! It will consist of bicycle rides in our nearby Feliciana's at St. Francisville, with home base at the Mary Ann Brown Nature Preserve (across from The Bluffs). The funds raised will benefit the Bluebonnet Swamp Nature Center and the Nature Conservancy of Louisiana.

The PARROT HEAD BIKE RIDE FOR OUR ENVIRONMENT is a ride designed and implemented by the Parrot Head Club of Baton Rouge for the benefit of the Bluebonnet Swamp Nature Center and the Nature Conservancy of Louisiana. The Bike Ride will take place in beautiful St. Francisville, LA and is produced by Parrot Head Club volunteers with the aid of local bike clubs.

It is a sporting event for all ages and athletic abilities.

It features both a 19-mile and 27-mile ride (approximately).

It is a community- and family-supported fundraising and public awareness event.

It is for seasoned riders, recreational and first-time participants, all supporting the cause.
